REQUIREMENTS TO OBTAIN AN INDIANA REAL ESTATE LICENSE

- You must be at least 18 years old
- Be a high school graduate or equivalent (G.E.D)
- Successfully complete the pre-license 90 hour broker transactions course.
- Pass the State of Indiana Exam
- Second se

TUITION

- \$499 (includes books and materials)
- A payment plan will be accepted for a \$50 fee. \$300 will be due upon registration and \$249 will be due ½ way through 90 hr class session.
- All students are responsible for the full tuition fee regardless of whether the class has been completed by the student. If a credit card was used for the first payment, we will charge the balance of the class on the card ½ way through the 90 hr class session

COURSE PAYMENT

- A \$35.00 fee will be assessed for any NSF check or any credit card charge not approved when processed.

REFUND POLICY
